ECORD Council Consensus 21-12-02:

The ECORD Council approves ECORD’s funding of the activities of Tim Reston, University of Birmingham, as IODP SEP Co-chair in FY22 for a total amount of \$80,000 USD.

ECORD Council Consensus 21-12-03:

The ECORD Council agrees that ESSAC and EMA should develop a process for MSP expeditions to: i. better involve external scientists (i.e., those who have not been invited to the Science Party - offshore and onshore) carrying out post-cruise research during the moratorium period, to increase inclusivity and to open the MSP programme to potential new member countries; ii. to increase opportunities for scientists to be involved in the onshore Science Party.

ECORD Council Consensus 21-12-04:

The ECORD Council agrees on the critical need to develop the general architecture of a post-2024 alliance of programmes, the International Ocean Drilling Partnership, and to seek partnership for this alliance in 2022. The ECORD Council prioritizes the development of partnership agreements to underpin the post-2024 alliance, before considering a financial commitment to the post-2024 use of the JOIDES Resolution when NSF is ready for a clear commitment.

ECORD Council Consensus 21-12-05:

The ECORD Council confirms its strong support for a Science Support Office and a proposal evaluation system to be under the umbrella of the alliance of programmes, the International Ocean Drilling Partnership, with all associated costs being shared by individual programmes.
